## **Planet over Profit?**

### **Nature Joins the Board of Eco Beauty Company**

In September, Faith In Nature announced the appointment of a new non-executive director for Nature. The natural world will now have a voice in its business strategy. "Through the model of legal personhood and 'guardianship', whereby nature is represented by a proxy on the board, Faith in Nature has given itself the mandate to take rights of nature into account in company decision making," commented Brontie Ansell (director of Lawyers for Nature) who will act as the non-executive director for Nature.

Patagonia: Mother Earth Becomes a Shareholder

"As of now, Earth is our only shareholder," Patagonia has announced. "ALL profits, in perpetuity, will go to our mission to 'save our home planet'." "[Patagonia Founder] Mr. Chouinard, his wife and two adult children have transferred their ownership of Patagonia, valued at about \$3 billion, to a specially designed trust and a nonprofit organization. They were created to preserve the company's independence and ensure that all of its profits — some \$100 million a year — are used to combat climate change and protect undeveloped land around the globe."

## **Rights of Nature Developments**

#### **Spain: Mar Menor Recognised as Legal Person**

The endangered saltwater lagoon, Mar Menor, was recognised as a legal person by Spain's senate this September. Under the new legislation, the lagoon in Murcia has the right "to exist as an ecosystem and to evolve naturally" and the right to protection, conservation and restoration. "There's still a lot of work ahead, but today is a day to celebrate," the Pact for the Mar Menor Platform said in a tweet, adding: "The Mar Menor has made history and so have the more than 640,000 people who signed their names so that it could have legal status as a person."

#### **Australia: Mornington Peninsula Council Resolution on Rights of Nature**

On 18th October, Mornington Peninsula Shire Council passed a resolution to explore the impacts of adopting Rights of Nature as a foundational framework for its future strategies. "While Local Councils do not currently have the power to create Rights of Nature laws, by using the framework of the Rights of Nature, the Council can begin important new conversations about how to build a regenerative, sustainable future for their unique local communities and ecosystems," commented Councillor Debra Mar.

#### **England: Rights of the River Deben Declared**

Organised by Save the Deben campaigners, in late September around 300 people gathered for the declaration of the rights of the River Deben. "Sailors passed 'the declaration of the rights of the river' from boat to boat before it was read out by guest speaker, barrister Paul Powlesland – co-founder of Lawyers for Nature – and signed by the town's Mayor, Patrick Gillard. 'Today was a drawing of a line in the sand,' said one of the event organisers, Ruth Leach. 'Our river is in a bad state and we need to raise our voices. We need to say we're not standing for it and our rivers have rights."

#### **Rights of Nature Global Gathering**

This October the Global Alliance for the Rights of Nature (GARN) hosted a global gathering in Siena, Italy. "The overarching goal...was to define a framework of action to keep expanding the global implementation and integration of the Rights of Nature all around the world." Among the outcomes, participants co-drafted *The Seed of Siena Declaration*: "We are all nurtured by the same sunlight and moon and share the same breath of life from the forests, grasses, oceans and sky.
